



## Remington Community Garden PAVILION RESERVATION AGREEMENT

The Pavilion may be reserved for private functions by calling the Remington United Methodist Church Administrative Assistant at (540) 439-2579 or by emailing: remingtonmethodist@gmail.com Please DO NOT post reservation signs. The church will coordinate and post ALL reservations.

## **PAVILION RULES:**

- Pavilion hours are from sunrise until sundown. Extended hours may be arranged.
- Fires are permitted in the charcoal BBQ grills only.
- Extra grills for larger crowds are permitted; however, they may NOT be used under the pavilion roof.
- Operation and parking of vehicles is permitted only on the gravel parking lot.
- Pets must be on a leash. ALL droppings must be cleaned up and removed.
- Put all trash, garbage, and litter in garbage bags and take home with you.
- Electrical receptacles are available inside the pavilion.
- When using electrical receptacles in the pavilion, plug in ONLY TWO electrical items in each receptacle.
- Turn off all inside lights and fans when leaving the pavilion.
- Decoration of the pavilion is limited to what can held in place through clamps or rubber bands. Use of nails, tacks, staples, screws, or any other item resulting in holes are prohibited. Please remove all decorations at the end of your reservation.
- Picnic tables may be moved for your convenience. Please return them to their original location before leaving.
- Return the pavilion in the same condition in which you found it. Please leave it ready for the next guests!

## The Following Are Prohibited in the Pavilion/Garden Area:

- Removal of any garden vegetables, plants, or flowers without **explicit permission** of the individual gardener.
- Distribution, selling services, soliciting without a permit.
- Alcoholic beverages or illegal drugs.
- Indecent or threatening language, or any abusive or indecent acts
- Disturbance of bird nests, eggs, or any other wild habitat.
- Erection of any temporary/permanent structures, such as tents, etc., without prior permission from the Garden Coordinator.
- Walking through the garden area(s) after sundown.
- Intentional breaking, cutting down, removing, injuring, or damaging any garden plants, ornaments, trees, plants, shrubs, ferns, flowers, or turf.
- Carrying of firearms, BB guns, air rifles, bows, arrows, slings, slingshots, fireworks, or other weapons.
- Damaging, destroying, defacing, adding to, or removing property, including picnic tables & grills.
- Defacing or destroying any notices, rules, or regulations that are posted.
